

**Exclusive to OCBC Al-Amin Bandar Botanic – OCBC Cash Tornado 2018 Promotion
Terms and Conditions**

1. The Promotion

- 1.1. The OCBC Cash Tornado 2018 Promotion (“Promotion”) offers customers during the promotion period i.e., on 3 August 2018, the opportunity to grab as much cash as possible in the Cash Tornado Machine within the allocated time, subject to conditions herein.
- 1.2. This Promotion shall be valid at the OCBC Al-Amin Berhad (“OCBC Al-Amin”) Bandar Botanic Branch for the promotional period (“Promotion Period”) stated as follows, or such date as may be determined and notified by OCBC Al-Amin at its sole discretion from time to time, as displayed in Table (1)

2. Eligibility

- 2.1. The Promotion is open to all individual Malaysian residents, Permanent Residents and non-residents*; excluding corporate customers and staff of OCBC Al-Amin, e2 Power Sdn Bhd and immediate families.
**Subject to country of origin*
- 2.2. Customers must take up or purchase any said product listed in Table (2) from 23 July 2018 to 3 August 2018 (both dates inclusive) to qualify to enter the Cash Tornado Machine.
- 2.3. Customers whose accounts with OCBC Al-Amin have been suspended or terminated or who have breached any other agreements with OCBC Al-Amin are not eligible.

3. Promotion Mechanics and Conditions

- 3.1. To qualify to enter the Cash Tornado Machine, customers must take up or purchase any said products as listed in Table (2).
- 3.2. Table (2) illustrates the product to be purchased and the associated value and time in order for customers to qualify for the cash tornado promotion.

- 3.3. Customers may appoint a family member or representative if he or she cannot participate in the Cash Tornado Machine for any reason whatsoever.
- 3.4. Customers or their representatives who enter the Cash Tornado Machine (“Participants”) are subject to the following:
- 3.4.1. Participants must be at least 18 years of age, whereas Participants over the age of 60 are discouraged.
- 3.4.2. Participants must be in good physical and health condition to participate. Persons with back, neck, knee or joint injuries, respiratory problem or who may be pregnant should not participate. Those currently under medical care are advised to consult his/her physician before participating on this event.
- 3.5. Once in the Cash Tornado Machine, Participants are to grab as much cash as possible subject to the following rules and regulations:
- 3.5.1. Participants must stand upright and cannot bend at the waist or knees to pick up cash from the floor.
- 3.5.2. Cash must be grabbed from the air and not from those trapped on the side of the wall of the Cash Tornado Machine.
- 3.5.3. Participants are not allowed to put the cash into their pockets, under their shirts, dress or any garments they have on.
- 3.5.4. Only cash grabbed in the air and still in the palm of participants after the stoppage time /expired time will count as valid.
- 3.5.5. Participants to start grabbing the cash after the sound of the first whistle and must stop once they hear the second whistle.
- 3.5.6. Participants to leave or exit Cash Tornado Machine once the time allocated has expired.
- 3.5.7. Any participants found not following the rules will be disqualified and any decision or repercussion set by the judge(s) or person(s)-in-charge is final.
- 3.6. When the Cash Tornado is ready for first time usage at the start of the day of the Promotion Period, a total of RM6,000 in various denominations such as RM1, RM10, RM50 and RM100 will be available in the Cash Tornado for the Promotion.

4. Other terms and conditions

- 4.1. All existing terms and conditions governing all products or programmes shortlisted in Table (2) under clause 3.2 will continue to apply.
- 4.2. All promotional conditions applicable for the Promotion are subject to change by OCBC Al-Amin at its absolute discretion with prior notice.

- 4.3. OCBC Al-Amin and each of its members, officials, staff, employees, agents and/or volunteers, will not be liable for any body injury, loss of life, claim, action, loss, damage, cost and expense, directly or indirectly arising out of or in connection with the participation of such activity(ies), including but not limited to any losses, injuries or death that may occur during, or after such activity(ies).
- 4.4. OCBC Al-Amin may, at its sole discretion, vary or add to these Terms and Conditions; or vary, suspend or terminate the Programme with prior notice to the customer(s). Variations or additions to these Terms and Conditions or the variation, suspension or termination of the Programme may be made by placing a general notice in any one issue of a daily national newspaper or by posting a general notice in any OCBC Al-Amin branch or its website or by incorporating the notice into OCBC Al-Amin's statement sent to the customers periodically and the notice will take effect from the date set out in the notice and, if no date is stated, will take effect from the date the notice is sent.
